## Rex Allen Days Vendor – SUPPLEMENT checklist

**Please check one of the following and return with Vendor Application:**

City of Willcox business permit:

- I understand that I am responsible to file my transaction privilege with the state and report all sales at this event, then remit the tax due.
- I understand I will be expected to contact the City of Willcox at 520 384-4271 and arrange to purchase my own business license for the weekend. The Keiller Park Staff will come to see a copy of my acquired license upon set-up in the park.

Cochise County Health Dept. permit:

- **I am a food vender, and I have a permit and will display onsite OR I don't currently have a Cochise County Health Permit, and understand I am responsible for contacting the county and acquiring a permit.** The current County application states the application and fees for the Health Department is to be submitted 2 weeks prior to the date of the event. This allows for proper staffing and the ability to call the vendors with any questions.

**501(c) Information:**

- I am a non-profit organization or am just giving out information and am exempt from taxes.

This is a juried event; pictures of setup have been emailed to [park@rexalldays.org](mailto:park@rexalldays.org) or are otherwise included with application. Not including pictures will not preclude a vendor from participating, however, those submitting pictures will be given priority over those who have not.

Vendors are expected to be open during all times the rodeo is open. No vendor shall breakdown their booth/etc while guests are in the Arena area. Allowable hours: vendors may breakdown and leave between 6pm and midnight. Vendors open on Sunday shall not breakdown their areas until the rodeo has closed at 5pm.

Vendors are expected to keep your areas clean, and to use the dumpsters, not park trash cans, to deposit garbage. An additional \$150.00 will be added to the following year's fee for those vendors not following this rule.

**FOR YOUR INFORMATION**

- Quail park is located on Fort Grant Road 1 mile West of Exit 340 on the west side of Interstate-10.
- Overnight RV camping is allowed, but there are no hookups.
- We have scheduled arrival and set-up times. Please choose a SET-UP time on application and coordinate with rodeo chair.
- Gates will be kept locked if you need to use your vehicle for transportation - park outside the fence.
- Good restroom facilities are available in arena area.
- Hotels, restaurants, and shopping are in walking distance, **book rooms early.**
- Vehicles are only allowed in certain areas of the Arena, you will be directed where to drive or park for setup/break down
- **Please email registration questions Nicole Zupan at [park@rexalldays.org](mailto:park@rexalldays.org) with questions.**
- We may have ice for sale at the arena, please check with the beer garden to verify this.
- Electricity and water are available bring extension and garden hoses as needed.
- **No exclusive rights to sell items are Implied**, but we will take care to not book too many of one item. **Contact Nicole if you have exclusivity requests.**
- Carnival location at Keiller park, on the East side of Interstate 10. If you'd like an additional sales booth here, let us know.
- Please use alternative hold downs, **and if you use stakes notify arena staff *before*** you drive them in.
- **FOOD VENDORS: If you do not have a Cochise County permit** Please call Cochise County Health Dept. 520-432-9400 and/or fill out the form and return with required fee.
